

VAT EXEMPTION QUALIFICATION

Zero Rated Vat

When purchasing a riser / recliner chair from FineBack Furniture you may be entitled to purchase certain goods with zero rated vat, i.e. claim exemption from vat and it is important to ascertain that you or the person who you represent is eligible.

How do I know if I am entitled to Vat relief

To become eligible you must declare that you are chronically sick or disabled, i.e. that you suffer from a physical or mental impairment which has a long-term and substantial adverse effect upon your ability to carry out everyday activities.

If you have any doubts concerning your eligibility for Vat relief, please contact the Customs & Excise National Advice Service on 0300 123 1073 or your local VAT office. For more information you should consult the VAT notice 701/7 VAT – reliefs for disabled people.

Which products are eligible for Zero Rating of VAT

Only those products which display the Vat Exemption pdf will be eligible for vat exemption. i.e. Riser recliner chairs

How is my order processed with Vat Relief

1. Download the Vat Exemption Form supplied in pdf format.
2. Place your order from our website as normal. You will not be charged Vat on the goods which are eligible for vat relief.
3. Fill out the form with your name and address, stating your medical condition and sign the declaration at the bottom. You will then need to return this document to FineBack Furniture with the address stated at the top of the form.
4. Where a customer has purchased a riser-recliner chair under the vat exempt regime, we cannot dispatch your goods until the form has been received. Upon receipt of the form, FineBack Furniture may need to speak to you regarding your eligibility.

FineBack Furniture will retain your declaration and HM Customs & Excise may request to view the document as evidence of your eligibility.
